BRUSSELS – On 29 May 2011, more than 320 lawyers and staff from national and international law firms in Brussels will once again join together as a single team to participate in the annual 20 km run through Brussels and raise money for charity. In celebration of its 200th anniversary, the Bar of Brussels is also fielding a large number of its lawyers to join the team.
